
The proposal was appraised by SEAC considering Form I, Form IA, field visit report and all other documents and details provided by the proponent as sought by SEAC during the appraisal process. Though omitted out in the Form I application, it is observed that the project site falls in Idukki Village which is categorised as an ESA Village in the Western Ghats by the MoEF &CC. Construction activity as proposed in the application is prohibited in such areas. Hence, the Committee decided to **recommend to reject** the proposal.
