

**MINUTES OF THE 34th MEETING OF STATE LEVEL ENVIRONMENTAL
IMPACT ASSESSMENT AUTHORITY (SEIAA) KERALA HELD ON 24.10.2014 at
HARITHASREE HALL, DEPT. OF ENVIRONMENT AND CLIMATE CHANGE**

Meeting commenced at 10 .30 am

The Chairman welcomed the members of SEIAA and briefed on the abstract of the agenda. The Chairman also briefed SEIAA about the income generated for the State, total job opportunities created and the total built up construction area for the State by the developmental projects cleared by SEIAA since it was established.

The Authority wanted the agenda notes at least 3 days prior to the meeting of SEIAA. The Authority noted that all except 4 applications for removal of ordinary earth have been recommended for EC by SEAC.

The Member Secretary appraised the Authority of the deliberations at the instance of the MoEF on appointment of a Regulator in matters connected to Environmental Clearance. In pursuance of a judgement of Hon'ble Supreme Court of India, MoEF took up the matter with the State Governments to ascertain their views. Member Secretary explained the salient features of the proposals on appointment of the independent Regulator. The general view was that the Regulator shall not be another power centre. Government of India may have appellate powers on the orders of the Regulator. Functions and responsibilities of the Regulator in the matter of nomination to SEAC, accreditation of the consultants and in ensuring the quality of the EIA Report shall be fixed. The agency having the power for enforcement shall have direct link with the Regulator.

The Member Secretary raised the question of levying processing fee for applications for Environmental Clearance, with early effect. The Chairman mentioned that a proposal for realising one time processing fee for Environmental Clearance applications was already submitted to Government of Kerala, which is still pending. The Member Secretary wanted fresh proposals covering all projects to be submitted to the Government forthwith.

Authority was informed that the action taken for implementation of the judgement of the Hon'ble High Court of Kerala in W.P.No. 4174/14 filed by Sri. Scaria Scaria and 21259/14 filed by Sri. Kuttichan (Item No. KLA/ 33.27 in file No. 73/SEIAA/168/2013). It was decided that SEIAA may hear Sri. Kuttichan after the report of SEAC is received.

The Authority wanted to systematise the procedure and streamline the works.

It was also decided to develop software by a Government agency, for online application. The agency may be engaged after consultation with experts.

DoECC reported the action taken on engagement of project personnel on contract basis for the plan scheme of 'Environmental Impact Assessment'. As decided in the 33rd meeting (Item 33.31.02) 8 candidates having the required qualifications, experience and who secured the highest rankings have been short listed. DoECC sought approval and sanction for engaging the first 4 persons from the short list. Authority approved the suggestion and wanted intimations to be sent urgently so that the selected persons could join by 1.11.2014. In case any candidates failed to turn up, offer letter may be sent to the next in line.

The committee confirmed the minutes of the 33rd meeting of State Level Environment Impact Assessment Authority (SEIAA). The Authority took up the agenda items one by one and unanimously resolved as follows:

Decision: The Authority considered the application and connected reports in the light of the report of the SEAC and prefeasibility reports and explanations submitted by the proponent. The application is for Mining of 1,80,000 MTA of building stone in 3 hectares interlinked with a crusher unit located within the complex. It is specifically declared in part III (Environmental Sensitivity) S.No. 9 of Form I Application against the query on areas occupied by sensitive land uses (Hospital, School, Places of worship, community facilities) that there is a Govt Hospital at Konni (4 km west) and a High School at Iravon (4 km west) .It is also stated S.No. d II on distance from the site to the nearest religious places like Church, Temple, Mosque that the St.Marys Church, Aanakuthy is 1.5 km, Murinjamanalam Mahadeva Temple is 3 km and the Mosque Konni is 5 km away. The SEAC 32nd Meeting considered the explanations and clarifications given by proponent on the queries by the committee since its 15th Meeting along with the Site Inspection Report of the subcommittee of the SEAC which inspected the site on 23.09.2013. At present there is a temple **79 m** away from the proposed mining area. However the committee for proponent the project subject to the condition that a safe buffer distance of 100 m should be maintained from the temple from the eastern side. There is another condition that the boundary of the quarry area to be fenced should have at least 100 m safe distance from the settlement on western side. It is also recommended that the crusher be located in the area away from settlement for minimum dust and noise

generation. Complaint against the quarry has been appeared in print media. The Authority received two complaints stating that the Kachanathu kotta temple, Muringamagalam temple, Thycavu mosque, Schools, Anganvadies and colonies are there adjacent there quarries. The water tanks of a few water supplies schemes are also setup on top of the rocky terrain nearby. The quarry is within 15 meters of the houses and there are residences around it. It is requested that environmental clearance may not be given to the quarry.

In Sl.No. 3.4 of Section II of the Form 1 Application on vulnerable groups of people who could be affected by the project, the proponent has declared that “ There are some houses within 500 m radius from the proposed quarry and the nearest house is located 107 m NW”. However he has filed a notarized affidavit that “I solemnly affirm and agree to keep a buffer distance of 100 m from the temple and from the settlements”.

The Authority examined the position in detail. The applications contain incorrect statements. Also there are serious complaints against granting EC. The Authority finds that it is impracticable to implement condition on buffer distance of 100 m from the temple which is 79 m from the quarry. Also there are habitations very close to the project site. The Authority therefore decided against grant of Environmental Clearance to the quarry project as applied for, and therefore to reject it.

Decision: After detailed discussions on the proposal and analyzing the appraisal report of SEAC, the proposal is **Approved for issuance of Environmental Clearance** stipulating the following specific conditions in addition to the usual general conditions:

1. The rare plants existing in the area may be removed and replanted in Sy. No. 682/A Successfully.
2. A large sized rain water harvesting pit to be provided in the north western part of the project site. All the storm water from the area must be channelized into this pit.
3. The overburden at the site and rejects from the plant at Nileshwar must be used for backfilling the pit.
4. One percent of the profit shall be given to the concerned Panchayath for Biodiversity Management Committee towards eco-restoration
5. The activities under CSR as per legal norms (2%) should be need based with special emphasis on education, health, poverty alleviation and infrastructure development in the neighbouring gramapanchayats of the the project.

Item No. KLA/34.34: Environmental clearance for the proposed quarry project in Sy. Nos.

Decision: The Authority approved the proposal for issue of environmental clearance subject to the general and special conditions as per the recommendations of SEAC. Numerous streams originate from the zone and two moderate streams originating in these hills flow through the boundary of the lease area. The catchment area of these streams exceeds 500 ha and the flow is significant. The quarry proposed at an elevation between 450 m to 350 m. Natural vegetation is seen on the hill top. The Kannavam RF is in visible distance. Based on the observations, following points may be taken into consideration:-

1. Changes in slope profile with break in slope, debris mantled nature of the hill slopes, presence of streams that originate in Western Ghat region and feed Mahe river etc. point to the unstable nature of the region. Landslides have been reported from further east of the area around Valayam.
2. The area shows the presence of several small abandoned pits disturbing the natural landscape.
3. Considering the steeply sloping nature, the quantity of rock that can be quarried, after providing benches and with 45 degrees slope, is limited and eco-restoration will be a difficult task.
4. Occurrence of good virgin top soil makes the area suitable agricultural activities.
5. The distance to be covered negotiating steep slopes to transport the material to the users is more than 10 km.
6. The changes to the landscape due to the quarrying operation in the mid-slope region of a rectilinear segment of Western Ghats is undesirable as it will alter the surface and ground water flow, decrease in vegetation cover, increase sediment load and can even induce landslides.'

The SEAC recommended that the proposal may be rejected for the above reasons.
