**Item No. KLA/01.01**

Application for obtaining environmental clearance for the proposed construction of Green Field Stadium at Kariyavattom, Trivandrum in Survey No. K-2315

The matter was discussed in detail and it was decided that the agenda should include a detailed note from the Secretary, SEAC incorporating the salient features of the project, all the issues that have been examined by the SEAC with strength and weakness. If there is any weakness from environmental point of view, mitigation measures shall also be given by the committee. The note shall also include detailed recommendations of the committee.

The item was deferred and the Director, DoECC was directed to have additional detailed notes for circulation and final approval thereon.

**Item No. KLA/01.02**

Application for obtaining environmental clearance for the proposed construction of "Cyberpark" - IT Building project, at Nellicode and Pantheerankavu Village, Olavanna Taluk, Kozhikode District, Kerala, in Survey Nos. 110/5, 10/5 & 111/8

The item was deferred and the Director, DoECC was directed to have additional detailed notes for circulation and final approval thereon.

**Item No. KLA/01.03**

Request for withdrawal of application for environmental clearance of proposed Service Apartment cum Tourist Village project at Sy. No. 84 (Re-Survey No. 5/3), Pallikkunnu Panchayat & Sy. No. 264, 260, 84 (Re-survey No. 178/5, 179/5) Chirakkal Panchayat, Kannur district, Kerala by M/s MIR Builders & Developers Pvt. Ltd.

The matter was discussed in detail and it was decided that the concerned local body shall be addressed to find out the present status of the land and to report as to whether any building permission has been issued for this project and any construction activities are started by the proponent, so as to ensure that there are no violations.
